Sub:- Admissions for the academic year 2018-19 in existing BHMS Course with intake capacity of 100 seats at Ram Krishna College of Homoeopathy & Medical Sciences, RKDF University, Airport, Bypass Road, Gandhi Nagar Campus, Bhopal, M.P reg. Sir.

This has reference to Ministry's letter of even No. dated 18<sup>th</sup> October, 2016 wherein a Letter of Permission was issued to Ram Krishna College of Homoeopathy & Medical Sciences, RKDF University, Airport, Bypass Road, Gandhi Nagar Campus, Bhopal M.P with intake capacity of 100 seats in BHMS course for the session 2015-16 and the college administration was asked to develop the requisite infrastructure for II<sup>nd</sup>, III<sup>rd</sup> and IV<sup>th</sup> Professionals well in time as per the CCH norms which will be verified and reported by the CCH at least three months before the start of next professional and accordingly, the permission for taking admissions in subsequent academic session will be issued. Further, vide Ministry's letter dated 31.08.2017, the college was granted permission for the academic year 2017-18 to take admission in I-BHMS and continue admission in IInd BHMS course under section 12A of HCC Act, 1973.

2. In order to verify the compliance of the College, the Board of Governors to CCH has conducted inspection of Ram Krishna College of Homoeopathy & Medical Sciences, RKDF University, Airport, Bypass Road, Gandhi Nagar Campus, Bhopal, M.P on 13.06.2018 and furnished the recommendation as under –

"Recommended for allowing admission in I-BHMS course and continuation of II-BHMS and III BHMS course for the session 2018-19 with the intake capacity allowed earlier subject to the removal of deficiencies reflected in the report of inspection before 31.12.2018".

3. In this regard, I am directed to say that after careful consideration of the recommendations of the executive committee to the board of governors to CCH in terms of the provision of the HCC Act 1973, relevant regulations made thereunder, the observation of the designated hearing committee of the Ministry of AYUSH, Policy of the Central Govt., Permission of the Central Government is hereby granted to Ram

Krishna College of Homoeopathy & Medical Sciences, RKDF University, Airport, Bypass Road, Gandhi Nagar Campus, Bhopal, M.P for taking admissions in 1<sup>st</sup> BHMS Course and for continuation of II-BHMS and III BHMS course for the session 2018-19 with 100 students under Section 12A of the HCC Act, 1973 subject to condition that the college shall fulfill the following requirements by 31st December, 2018 -

- i. All the minimum standard requirements of infrastructure and teaching & training facilities as specified in Regulation 3 of the "Homoeopathy Central Council (Minimum Standards Requirement of Homoeopathic Colleges and attached Hospitals) Regulations 2013" by 31<sup>st</sup> December 2018 and
- ii. All the requirements under the provisions of the HCC Act, 1973 and relevant Regulations made thereunder should be fulfilled *in toto*.
- 4. The college administration will ensure that sufficient qualified teachers and non-teaching staff in the college and requisite staff in the hospital, as per the relevant CCH Regulations are in position before starting IVth Professional of BHMS course is made, under intimation to the Central Government and CCH.
- 5. The college has to develop the requisite infrastructure for IV<sup>th</sup> Professionals well in time as per the CCH norms. The College has to comply with the full requirements of HCC (MSR) Regulations, 2013 by 31<sup>st</sup> December, 2018 for continuing admissions during the subsequent years. A copy of the compliance report shall be submitted by the college to CCH under intimation to this Ministry. Subsequently, CCH shall verify the compliance well in time for considering the admissions during the Academic Year 2019-20 and furnish the recommendation to the Central Government.
- 6. The college administration may take up the matter for recognition of the qualification as per the provision of HCC Act, 1973 at that time when the first batch of students admitted against this course appears for the first final professional examination of the said course.
- 7. Please acknowledge the receipt of this letter.
