WHEREAS, in terms of section 14(3)(a) of the NCTE Act 1993, WRC granted recognition/permission to VEDICA SIKSHA MAHAVIDALYAYA, C/O SWAMI VIVEKANAND H.S. SCHOOL, 85 DURGA CHOWK, BARKHERI, BHOPAL 462003 MADHYA PRADESH vide order dated 09-08-2005 & formal order issued on 14-08-2007 to start the B.Ed. (CO-ED) Course with an annual intake of 100 students.

AND, WHEREAS, WRC issued Revised Recognition order to VEDICA SIKSHA MAHAVIDALYAYA, C/O SWAMI VIVEKANAND H.S. SCHOOL, 85 DURGA CHOWK, BARKHERI, BHOPAL 462003 MADHYA PRADESH vide order dated 31.05.2015 for conducting B.Ed. (Co-Ed.) course of two year duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-16.

AND, WHEREAS, the institution applied for Change of University from Barkatullah University, Bhopal to **R.K.D.F. University, Bhopal University** and name of Vedica Shiksha Mahavidyalaya to **Department of Education**.

AND, WHEREAS, a application was submitted by the institution on **02-09-2016** with a request for shifting premises with necessary fees.

AND, WHEREAS, the matter was placed in **276th Meeting of WRC held on May 30-31, 2017** and the Committee decided that "...Regarding the Vedica Shiksha Mahavidyalaya (223271 - B.Ed.) NOC has been given by the Barkatullah University vide order dt. 12/08/2015. **Therefore, change of affiliation of Vedica Shiksha Mahavidyalaya is permitted. It becomes the 'Department of Education' of RKDF University as requested by R.K.D.F.**

Vedica Shiksha Mahavidyalaya has applied for shifting its premises to RKDF University campus. As it has already paid the necessary fees, **VT be constituted.**"
