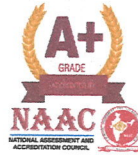



Ordinance no. 87

Open and Distance Learning and/or online mode course


1. The provisions of this ordinance shall be applicable to the courses offered in open in distance learning and /or online mode.
2. The open distance learning and/or online mode programs shall be offered as per the regulations and guidelines of Distance Education Bureau, University Grants Commission/ MP State Government/ University as ratified approved from time to time.
3. The University shall offer – Professional & Traditional Undergraduate/ Post Graduate courses (in Semester and/or Annual mode) for the award of certificate/diploma/ Degree/ P.G. Diploma/ Master Degree as approved by Board of Management of the University.
4. The university shall offer only those degree programmes as undergraduate, post graduate level and post graduate diploma programmes through Open Distance Learning and/or online mode which are been offering in conventional mode of classroom teaching and from which at least one batch has passed out.
5. Course and Intake:
  - a. The courses and intake shall be as approved by Board of Management/ Distance Education Bureau, UGC/MPPURC.
  - b. The intake capacity under Open and Distance Learning mode for a programme shall be three times of the approved in take in conventional mode or as approved by Distance Education Bureau of UGC.
  - c. In case of the programs falling under the Ambit of statutory regulatory/authorities, the university shall seek prior approval of concerned authority before starting the program in open and distance learning and/or online mode.
6. Admission and Eligibility:
  - a. The entry level qualification, curriculum, teaching learning scheme, pattern of question papers for end semester examination or term end examination, pass and fail criteria of program shall be same as per the conventional program conducted under regular mode in the university.
  - b. The admission of the programs shall be made in the following manner

- Annual Scheme: Admissions to the programs covered under the annual scheme shall be made normally from the month of July to October in each Academic year or as decided by University/MP State Govt./Government of India/Concerned regulatory agency.
  - Semester Scheme: Admission covered under the semester/ six month scheme shall be made normally in the month of July/ August in each Academic year or as decided by University/MP State Govt./Government of India/Concerned regulatory agency.
7. Curriculum and Syllabus:
- a. The curriculum and syllabus of the program shall be same as being offered in concerned program in conventional mode as recommended by Board of Studies and approved by Academic Council from time to time.
  - b. The University shall be prepare self-learning material of concerned course as per the approved syllabus and scheme and host it on University website.
  - c. The university programs in open in distance learning and/or online mode shall have total credits and minimum duration for the program kept same as that of corresponding program in conventional mode.
  - d. At least 60 percent of Self Learning Materials shall be developed by the in-house faculty of University and the remaining percent of the materials can be sourced from available resources such as other Higher Educational Institutions, Open Educational Resources (OER), and SWAYAM, duly approved by the statutory authorities of the University. University may allow up to 40% of the total courses being offered in a particular program in a semester through the online learning courses/Massive Open Online Courses.
8. Minimum and Maximum Duration of Programme:
- a. The minimum duration for completion and award of diploma/degrees at the undergraduate and postgraduate levels in Open and Distance Learning mode and Online mode shall be in accordance with the duration of the program offered in conventional mode/UGC notification of specification of degrees, 2014.
  - b. The minimum duration for completion and award of post graduate diploma shall be two years/four semesters;
  - c. The maximum duration for completion and award of degree at the undergraduate and postgraduate levels or post graduate diploma in Open and Distance learning mode and Online mode shall be double the minimum duration of the respective programmes as per items (a) and (b), above.

9. Examination and Minimum Pass Marks

- a. The examination of the programmes in Open and Distance learning mode and/or Online mode shall be conducted by University in accordance with the provisions of Ordinance no 4 and 5 of the RKDF University.
- b. All end semester examinations or term end examinations for programmes offered through Open and Distance Learning mode shall be conducted through proctored examination (pen-paper or online or computer based testing) within Territorial Jurisdiction at the examination center as assigned by University.
- c. Examination of all programs will be held at the end of Academic Session/ or Duration of course, as applicable, on the dates as notified by the University.
- d. Every candidate shall be examined in the subject(s) as per criteria laid down in the concerned scheme of Examination/ syllabus prescribed for the programme.
- e. Weightages for continuous assessment and semester examinations or term and examinations shall be in conformity with concerned regulations of distance education bureau.
- f. In every paper 30 per cent shall be evaluated through internal assessment remaining 70 per cent shall be evaluated through end-term examination at the end of semester/year
- g. The re-appear examinations of the students will be held along with semester/ annual examinations, as the case may be.

10. Evaluation:

- a. The evaluation shall include two types of assessments;
  - (i) Continuous or formative assessment; and (ii) Summative assessment in the form of end semester examination or term end examination, provided that the weightage for different components of assessment for both open and distance learning mode and online mode shall be as under:
    - continuous or formative assessment (in semester): Maximum 30 percent.
    - summative assessment (end semester examination or term end examination) Minimum 70 per cent.
  - b. The list of successful candidates after the completion of the final semester/ year examination of the concerned programme shall be arranged in division on the basis of the aggregate marks/grade obtained in his certificate/ Diploma/ Bachelor's degree/ Master's degree as per the regulation of RKDF University, Bhopal.



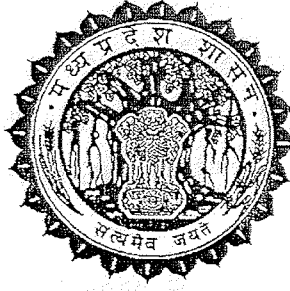

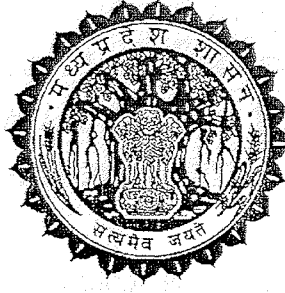
REGISTRATION OF STUDENT AND THERE ADMISSION TO THE COURSES OF  
STUDY AND TEACHING METHODOLOGY

- (1) For registration / to enroll in the University courses of study, a candidates must apply on prescribed format and submit the application form along with the attested copy of the mark sheet of the qualifying examination and University fees. The registration form will be forwarded by the head of the institution to the Registrant of the University.
- (2) On receipt of the registration form at the University Institution the candidates will be allotted a temporary registration number
- (3) The registration application form will be subject to verification by the University and after due verification, the candidates will be given a permanent registration number
- (4) The mode of sending application for admission of the student can be direct or counseling or through guidance centre or though post or through online. Any student from India or abroad seeking admission in the University can interact online to the University. Mode of instruction of teaching of such student shall be decided by the Academic Council of the University
- (5) The Validity of the registration of student for different - different course will be as under.

- (6) No person who is under sentence or expulsion or rustication from another University shall be admitted to any course of study during the period for which the sentence is in operation.
- (7) (i) A student who is registered with the University may apply for a change correction or alteration in one's own name or surname to the Registrar of the University with a fee decided by University.
- (ii) The Registrar, if he is satisfied with the reasonableness of the request, may pass order for change or correction of name of the student.
- (iii) The application for change or correction in the name shall be made through the Head of the institution where the student is studying or will be supported by an affidavit.

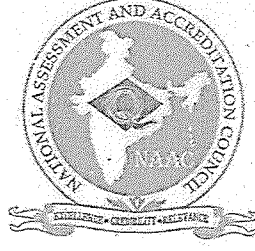

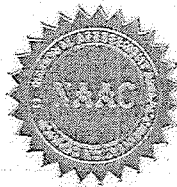

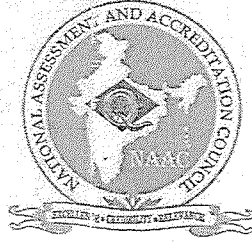
